## **TAX LEVY ORDINANCE 22-06**

## TAX LEVY FOR 2022-2023 NORTHERN MORAINE WASTEWATER RECLAMATION DISTRICT

AN ORDINANCE PROVIDING FOR THE LEVY OF TAXES FOR THE NORTHERN MORAINE WASTEWATER RECLAMATION DISTRICT, LAKE AND MCHENRY COUNTIES, ILLINOIS, FOR THE FISCAL YEAR BEGINNING MAY 1, 2022 AND ENDING APRIL 30, 2023.

WHEREAS, the Board of Trustees of the Northern Moraine Wastewater Reclamation District, Lake and McHenry Counties, Illinois, did on the 12<sup>th</sup> day of July 2022, pass the Annual Appropriation Ordinance for the fiscal year beginning May 1, 2022 and ending April 30, 2023, in the aggregate amount of:

EIGHTEEN MILLION THREE HUNDRED FIFTY-ONE THOUSAND SIX HUNDRED ELEVEN DOLLARS AND EIGHTY-FIVE CENTS (\$18,351,611.85).

which Ordinance, was duly published in accordance with statutes:

**BE IT ORDAINED**, by the Board of Trustees of the Northern Moraine Wastewater Reclamation District, Lake and McHenry Counties, Illinois as follows:

**SECTION 1:** A tax for the sums of money, or as much thereof as may be authorized by law to defray all expenses and liabilities of the Northern Moraine Wastewater Reclamation District, be and same is hereby levied for the purpose specified against all taxable property in the Wastewater Reclamation District for the fiscal year commencing on the 1<sup>st</sup> day of May, 2022 and ending on the 30<sup>th</sup> day of April, 2023.
