TAX LEVY FOR 2017-2018 NORTHERN MORAINE WASTEWATER RECLAMATION DISTRICT

AN ORDINANCE PROVIDING FOR THE LEVY OF TAXES FOR THE NORTHERN MORAINE WASTEWATER RECLAMATION DISTRICT, LAKE AND MCHENRY COUNTIES, ILLINOIS, FOR THE FISCAL YEAR BEGINNING MAY 1, 2017 AND ENDING APRIL 30, 2018.

WHEREAS, the Board of Trustees of the Northern Moraine Wastewater Reclamation District, Lake and McHenry Counties, Illinois, did on the 9th day of May 2017, pass the Annual Appropriation Ordinance for the fiscal year beginning May 1, 2017 and ending April 30, 2018, in the aggregate amount of:

FOUR MILLION TWO HUNDRED THIRTY-NINE THOUSAND TWO HUNDRED TWENTY-FOUR DOLLARS AND SEVENTY-SIX CENTS (\$4,239,224.76).

BE IT ORDAINED, by the Board of Trustees of the Northern Moraine Wastewater Reclamation District, Lake and McHenry Counties, Illinois as follows:

SECTION 1: A tax for the sums of money, or as much thereof as may be authorized by law to defray all expenses and liabilities of the Northern Moraine Wastewater Reclamation District, be and same is hereby levied for the purpose specified against all taxable property in the Wastewater Reclamation District for the fiscal year commencing on the 1st day of May, 2017 and ending on the 30th day of April, 2018.
