

TAX LEVY ORDINANCE

TAX LEVY FOR 2014-2015 NORTHERN MORAIN WASTEWATER RECLAMATION DISTRICT

AN ORDINANCE PROVIDING FOR THE LEVY OF TAXES FOR
THE NORTHERN MORAIN WASTEWATER RECLAMATION DISTRICT,
LAKE AND McHENRY COUNTIES, ILLINOIS,
FOR THE FISCAL YEAR BEGINNING MAY 1, 2014 AND ENDING APRIL 30, 2015.

WHEREAS, the Board of Trustees of the Northern Moraine Wastewater Reclamation District, Lake and McHenry Counties, Illinois, did on the 10th day of June 2014, pass the Annual Appropriation Ordinance for the fiscal year beginning May 1, 2014 and ending April 30, 2015, in the aggregate amount of:

ONE HUNDRED SIXTY FIVE THOUSAND ONE AND FORTY THREE CENTS (165,001.43),

which Ordinance, was duly published in accordance with statutes:

BE IT ORDAINED, by the Board of Trustees of the Northern Moraine Wastewater Reclamation District, Lake and McHenry Counties, Illinois as follows:

SECTION 1: A tax for the sums of money, or as much thereof as may be authorized by law to defray all expenses and liabilities of the Northern Moraine Wastewater Reclamation District, be and same is hereby levied for the purpose specified against all taxable property in the Wastewater Reclamation District for the fiscal year commencing on the 1st day of May, 2014 and ending on the 30th day of April, 2015.

SECTION 4: This Ordinance shall be in full force and effect from and after its passage and approval as provided by law.

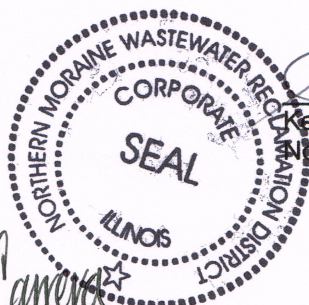
